In response to COVID-19

To help you prepare your trip to us, we'd like to inform you about the requirements, procedures and other practical information in response to COVID-19 to make sure you have everything in order. As a preparation on your trip to the Philippines

Travel requirements set by the Philippine government

To enter the Philippines, the government has set the following requirements. Please bring:

- An acceptable proof of vaccination;
 - a. World Health Organization International Certificate of Vaccination and Prophylaxis;
 - b. National/State digital certificate of the country which has accepted VaxCertPH;
 - c. Other proofs of vaccination permitted by the IATF (Inter-Agency Task Force).
- A negative RT-PCR test taken within 48 hours OR a negative ANTIGEN test taken within 24 hours before the time of departure from your country of origin;
 - * Please refer to our terms & conditions if you're not able to travel due to a positive test result.
- A valid return ticket within 30 days from the date you arrive in the Philippines;
- A valid passport for a period of at least 6 months at the time of your arrival in the Philippines;
- A travel insurance for COVID-19 treatment costs, with a coverage of min. USD 35.000 for the duration of your stay in the Philippines. Please do bring the policy or a (requested) official letter from your insurance wherein the amount is clearly stated.

Furthermore, before you arrive in the Philippines

Registration with One Health Pass

The Philippine government would like to receive some information from you prior to your arrival to make the arrival procedure smoother. They require all passengers/arrivals to register through the "One Health Pass" within 3 days before you arrive. To register, please visit www.onehealthpass.com.ph and click on the blue button "One – register".

Please have the following information ready, so it's easy for you to fill in the form:

- Your passport number;
- Your flight details;
- Date of vaccination administration;
- Photocopy/Scan of your PCR test result;
- Residence details. Please fill in the address of the resort you will be staying as noted on the next page. If you're making a combination trip, please provide the address of the first resort of your itinerary.

After you completed the form, you will receive a QR-code, which you need to have with you upon arrival in the Philippines.

TIP: make a print screen of this QR-code so you always have the code with you, even if you don't have internet access upon your arrival.

Testing procedure on your way home

Leaving the Philippines...

Does your country require a negative COVID-test when you're going home? We will assist you!

The big international airports of Manila and Cebu have their own testing facility on spot. Depending on your departure flight, you can get tested before you check in for your flight. That's why we have the following procedure:

Please note: this procedure is based on ANTIGEN testing (within 24 hours before departure).

If your government requires a (RT-)PCR test only, please contact us directly.

Leaving from Cebu airport

If you're leaving from Mactan-Cebu airport, we will bring you to the airport 2 hours earlier than in 'normal' situations.

Upon arrival at the airport, you will get tested in their testing facility and you'll wait for your test result.

Costs: 900 PHP / ±17 USD / ±16 EURO

Result: in 2 hours

Payment possibilities Credit card or cash (PHP)

If you're coming from Magic Oceans and don't have enough time to get tested at Mactan-Cebu airport due to the ferry schedule, we will make an appointment for you at the local Department of Health Center in Anda, Bohol, so you can get swabbed at the resort or we'll bring you to the nearest hospital.

Leaving from Tagbilaran airport

If you leave from Tagbilaran airport, there are 2 options for you to get a test. As you don't need a negative test result for domestic flights, we need to take the following options in consideration to be able to assist you with getting the test result in time, as well as within 24 hours before your international flight.

1) Leaving with a lay-over in Manila for a minimum of 2,5 hours

As you don't need a negative test for the domestic flight TAG-MNL, you may get tested at the international airport of Manila. There is a testing facility in terminal 2 and 3.

Costs: 600/700 PHP / ±12/14 USD / ±10/12 EURO

Result: in 30 minutes

Payment possibilities: Credit card, cash (PHP), PayPal, GCash, WeChat Pay, Alipay

2) Leaving with a lay-over in Manila for 2,5 hours or less OR an international flight out of the Philippines.

We will either bring you to the local Department of Health in Anda, or we will bring you to the nearest hospital on the way to the airport. Payment possibilities and costs depend on the location, but won't exceed 700 PHP / 14 USD / 12 EURO. The result takes about 1 hour, up to 2 hours maximum.
